

**To the Attorney General of British Columbia and Shannon Halyk, Regional Crown Counsel:**



We, the undersigned, respectfully request that Captain's killer, if found guilty, receives the maximum sentence allowable: 5 years of imprisonment. Captain, a two-year-old German Shepherd, dog was discovered bloody and near death in a dumpster in Vancouver British Columbia on July 18, 2012. He was emaciated and had been brutally beaten. He had lacerations on his head and neck and was unable to walk. He died one day after being removed from the dumpster. Police found a knife, baseball bat, heavy chain and animal feces in Captain's owner's home.

Please speak out against animal cruelty and help get justice for Captain by adding your signature to this petition. Also please give this petition to any animal-loving BC residents you know.
