

The Animal Control Officer applies to have four, unlicensed Pit Bull terrier or Pit Bull terrier cross dogs owned by the Respondent, destroyed.

The Animal Control Officer's grounds for the destruction order are that:


- (a) the dogs have seriously injured a person;
- (b) the dogs have killed or seriously injured a domestic animal, while in a public place or while on private property, other than property owned or occupied by the person responsible for the dog; and
- (d) he has reasonable grounds to believe is likely to kill or seriously injure a person.

The facts upon which the application is based are as follows:

1. On August 4, 2007 seven unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs and an unleashed Rotweiller or Rotweiller cross dog owned by the Respondent attacked and seriously injured a German Shorthaired pointer owned by Jeff Rowat of 1654 - 156a, Surrey BC.
2. On November 25, 2007: six or seven unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent surrounded and confronted Mr. August Albrecher of #2 - 2678 King George Highway, Surrey while he was jogging in a Surrey park. The dogs only retreated when Mr. Albrecher's friends arrived and chased the dogs away.
3. On December 12, 2007: five to seven unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent attacked Andrew Hutchinson of 2855 Countywoods Drive, Surrey BC. and his two leashed Labrador dogs while he was cycling in South Surrey Arena Park.
4. On March 28, 2008: four unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent attacked and very seriously injured a leashed Yorkshire Terrier owned by Mr. Lawrence Lewis of 2938 Ridgeway Road, Nanaimo BC. in a parking lot behind Rutherford Mall in Nanaimo.
5. On April 4, 2008: four unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent attacked two Pomeranians at a park located at 148<sup>th</sup> Street and 20<sup>th</sup> Avenue, Surrey. BC.
6. On June 19, 2008, two unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs and an unleashed German Shepherd or German Shepard cross dog belonging to the Respondent attacked and killed a Bichon dog called Tasha owned by Ms. Judy

Evans of Surrey, British Columbia while Ms. Evans was walking Tasha on a leash, near the 16000 block of Cranley Drive in Surrey.

- 7. On July 7, 2008 four unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent attacked and severely injured a miniature American Eskimo dog on Dickson Road in North Saanich. The Respondent was severely bitten by his own dogs during the fight and was taken to Victoria General Hospital where he received 51 stitches to close his wounds.
- 8. On August 10, 2008 four of five unleashed Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent attacked and seriously injured Jody Tomlinson and his Presa Canero in the vicinity of 14667-80<sup>th</sup> Avenue in Surrey, BC.
- 9. On August 11, 2008 four Pit-Bull terriers or Pit Bull Terriers cross dogs owned by the Respondent which were involved in the attacks were seized and impounded in the Surrey pound pursuant to subsection 149(8) of the *Community Charter*.
